

## **Chair's Report**

## **Governing Body meeting**

## 6 March 2014

This report summarises the business that I have conducted on behalf of the CCG during February.

Work continues with city-wide partners. Working with city-wide partners, I attended the Sheffield Executive Board and a further meeting of the Public Service Transformation Leadership Group.

At the time of writing, I am due to attend the Health and Wellbeing Board's strategy development meeting, which was preceded by a visit of the Cabinet Office to discuss health and social care integration with members of the Health and Wellbeing Board, our provider trusts, and voluntary sector colleagues. I will report on the discussions at the Governing Body meeting.

Also at the time of writing, I am due to attend the launch of the State of Sheffield 2014 report on 25 February. The report is produced every year by Sheffield Executive Board. It aims to provide an overview of what is happening in Sheffield, describing how things are now, how they are changing and how the city compares with others. The purpose of the report is twofold: to improve the shared understanding across the city of key trends, developments and challenges, and to also help in the process of setting shared ambitions and priorities. It is based on a wide range of existing data sources and reports already held within organisations in Sheffield, or organisations that are relevant to the city. It uses the most recent data and information available and is the only report which brings together information on economic, social and environmental trends and developments and is therefore a 'whole city' report. I will report on the events at the Governing Body meeting.

I was invited to attend the launch of phase 2 of the South Yorkshire, Bassetlaw and North Derbyshire Survivorship Programme, 'Living With and Beyond Cancer' on 7 February. The programme covers the next 18 months based on the original funding proposals from Macmillan, Cancer Research UK and Clinical Commissioning Groups (CCGs). Findings from all the local projects will be brought together to influence the design of a single service specification to define the role of the NHS, social care and the voluntary sector in supporting patients living with and beyond cancer. Phase1 funding has supported CCGs to continue to improve their local cancer services in terms of after care for patients living with and beyond cancer. The second phase is to design systems to support proactive patient management which will reduce the need for emergency admissions for a defined cohort of patients and will enable a planned approach for patients living with and beyond cancer

Finally, as part of my regional work, myself and CCG colleagues attended the South Yorkshire and Bassetlaw Commissioners and South Yorkshire, Mid Yorkshire and North Derbyshire Providers' Working Together programme workshop on the morning of 14 February. The purpose of the workshop was to give commissioners and providers an opportunity to come together and build on work undertaken to date; to agree how the

commissioners' and providers' work programmes can be aligned and complimentary; and to agree how to take this forwards in a formal and structured way.
