Key Messages for Governing Body from the Strategic Public Involvement, Equality and Experience Committee on 7 December were:	
<ul style="list-style-type: none"> • The proposal to undertake a coordinated approach to working with the voluntary and community sector around Commissioning Intentions and key priority pieces of work allowing the VCF sector to plan their capacity and funding. • A draft model for the strategic approach for commissioner led involvement, equality and patient experience in Sheffield has been produced to support the transition to the South Yorkshire ICB. The aim of the strategic direction for Sheffield continues to be putting resource to hearing the voices with the greatest health needs; to working more in partnership with the Council and expanding to more statutory organisations such as the fire service and police. It is built on a model of further investment in the voluntary and community sector, looking to provide a more sustainable model of longer-term funding working alongside partners. The importance of a committee like SPIEEC to provide assurance on involvement and equality duties is also recognised. The four CCGs and the central team have different ways of working, and it is not yet known what funding will be available across the ICS and Place. Workshops across the ICS are taking place, looking at what should be at Place and what should be at System level. SPIEEC will continue to explore future arrangements through a workshop in January. • The success and importance of the Covid vaccination engagement work and the 	

practicalities that had on the vaccination roll out, including the achievement of being the most vaccinated core City in the UK, and the reach of vaccinations across all the communities. An evaluation of the engagement work carried out in Sheffield during the pandemic and the public health impact should be publicised wider.
