For any bidding process for local commissioning of social prescribing funds I will not be involved directly in any detail. YAS will be advised of this and a link established with the Local Authority Lead Commissioner for Social Prescribing. For any decisions around social prescribing locally if YAS is involved I will declare an interest and remove myself from the decision making process. It is possible that new areas of conflict arise as the YAS role develops. If this happens any conflicts will be considered and declared along with appropriate mitigations. Oral and maxillofacial surgery (OMFS) is commissioned by NHS England and so I am unlikely to be directly involved in any procurement or bidding processes at local or ICS level that are relevant to OMFS. Should there be any decisions relating to OMFS in Sheffield I will declare an interest and I will absent myself from the decision making process. It is possible that new areas of conflict arise as the commissioning landscape evolves. If this happens any conflicts will be considered and declared along with appropriate mitigations. In relation to decisions relating to VAS I will declare the interest and agree appropriate mitigations with the Chair accordingly. In relation to discussion and input to the Board, conflicts of interest will also be declared and no information that might provide undue advantage will be shared.
